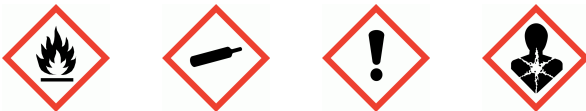

### SECTION 7: Handling and storage, including how the chemical may be safely used

#### Precautions for safe handling

##### **Usage precautions**

For professional users only. Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet.
